Vulnerable clients

FINRA has updated their rules to allow additional action to be taken when financial exploitation is suspected - use the Vulnerable Client Intake Form to submit any concerns to Cambridge

Amendments to FINRA Rule 2165 became effective on March 17, 2022 to permit firms to:

- place a hold on a securities transaction (in addition to the already-permitted hold on a disbursement of funds or securities) where there is a reasonable belief of financial exploitation; and
- extend a temporary hold on a disbursement or transaction for an additional 30 business days, beyond the current maximum of 25 business days (for a total of 55 business days) after first imposed unless it is terminated or extended by an order of a state regulator, agency, or court.
