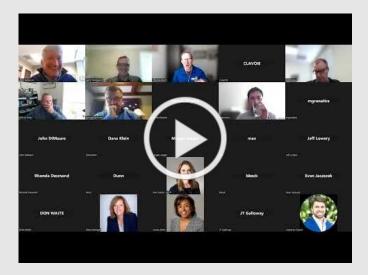

## Reminders: Advertising & Correspondence

Remember that you have until March of 2024 to retrieve any old marketing material from AdView and submit it to the new RegEd module (Communications Review). Watch the recording of today's call to see a demonstration of how to export your existing material from the AdView system.

Advertising and Hard Copy Correspondence will be submitted using the same system now. When submitting correspondence, keep the following in mind:

- Financial Professional must be listed as the "Originator" when submitting Correspondence, otherwise it will not route to your OSJ correctly, and it will not be retained. An admin submitting on behalf of the financial professional would be the Submitter, but the financial professional would be the "Originator"
- Remember to select "Suppress Expiration Emails" as that applies to Advertising, not Correspondence. If left unselected, you will get an email in 2 years saying that it is expiring (which again only applies to Advertising).
