## **Off-channel Communications Reporting**

On October 29, 2024, Cambridge announced the implementation of an **Electronic Communications Training** for all newly associated persons who join on or after November 1, 2024. One important item included in that training was the implementation of a centralized reporting address so that supervisors and financial professionals can report instances of off-channel communication when they occur. This policy will be effective for instances of off-channel communications that occur beginning November 1, 2024.

Going forward, whenever an instance of off-channel communication occurs, the off-channel communication should be forwarded to the email address offchannel@cir2.com. Forwarding the off-channel communication will both notify the firm of the off-channel communication, and will ensure it is retained within a compliant communications channel at the cir2.com domain.
