

### **Abandoned Property and Quarterly Transfer**

Pershing will process their quarterly abandoned account transfer on Monday, March 24, 2025. After assets are transferred into Pershing's abandoned property range, they are no longer visible to Cambridge or our financial professionals. Accounts eligible to be transferred have either a Returned Mail restriction or an Abandoned Account restriction on them. If an account has either of these restrictions, please use CLIC to update/confirm the client's current mailing address by Friday, March 14, to prevent the assets from being transferred into Pershing's abandoned property range.

At the account level, Returned Mail and Abandoned Property events can be monitored via the *Abandoned Property Profile* link on account's Profile screen in NetX360+. To monitor for Returned Mail and Abandoned Property across all of your clients' Pershing accounts, it is recommended that you use the *Returned Mail – Lost Security Holder* IFA. Step-by-step instructions for this process and how to update accounts can be accessed by clicking **this link**.

Assets that have been transferred to abandoned property remain retrievable on a best-efforts basis until they are escheated to the state at a time dictated by state law. The process to retrieve transferred assets can be initiated by opening a CLIC® Service Request using the topic *Pershing Retirement Accounts* or *Pershing Retail Accounts*. Upon escheatment, clients would follow their state guidelines to reclaim their property.

### **Monthly Fee Billing**

Billings for Monthly Review for CMAP and WealthPort accounts are available for review starting March 4 – March 6. These billings will be pulled back from review March 6 at 8:00 a.m. CT. Please free up any cash and make changes to the billing before March 6 at 8:00 a.m. CT.



### **Investment Management Updates - CAAP**

Russell Balanced Growth and Moderate Growth Portfolio and Potomac Guardian Strategy and Potomac Bull Bear Strategy is available in WealthPort CAAP and UMA effective March 3, 2025.

These are material changes; the WealthPort Wrap Client Agreement and Application version dated 102324 will continue to be accepted through April 3, 2025. As of April 4, 2025, the WealthPort Wrap Client Agreement and Application version date 030325 will be required, and the older version dated 102324 will no longer be accepted.

### **AXA Equitable Trail Change**

AXA Equitable will now be paying trails monthly, rather than quarterly, starting in April 2025. The last quarterly payment will post in April (for January, February, and March). May will start monthly payments (April monthly will pay in May).


